# **Injured Pandoles shifted to** Mumbai via 'green corridor'

YOGESH NAIK MUMBAI, SEPTEMBER 5

GYNAECOLOGIST ANAHITA Pandole and her husband Darius Pandole – who were injured in a car accident on Sunday afternoon which also claimed the lives of Tata Sons former chairman Cyrus Mistry and Jehangir Pandole, director at KPMG Global Strategy Group — were shifted from the Rainbow Hospital in Gujarat's Vapi to H N Reliance Foundation Hospital in Mumbai via a 'green corridor' on Monday morning.

The staff of H N Reliance Hospital and traffic police teams of Valsad, Palghar, Mira-Bhayandar and Mumbai worked together to create the green corridor. The ambulances started from Vapi at 6 am and reached the hospital in Mumbai around 9 am on Monday, said sources.

Dr Tejas Shah, who runs Rainbow Hospital, located 50 km from the accident site, said, 'When Dr Anahita was brought to our hospital... her oxygen saturation level was between 45 and 65 (normal range is 97-99). She had pelvic injuries and there was loss of blood from the pelvic region. Blood had accumulated in her chest. We could not take her for CT scans... we stabilised her in the ICU. After two hours, she and her husband started responding." Dr Shah said an aircraft was

They were critical but became more stable by midnight. Two cardiac ambulances with intensivists also came to our hospital after midnight and the process of creating a green corridor started. We informed Valsad police to create a green corridor as they help us shift patients in many

# Mistry's autopsy reveals severe head trauma, multiple fractures

Mumbai: The preliminary autopsy of former Tata Sons chairman Cyrus Mistry revealed that he sustained severe head trauma and multiple fractures in chest, head region, thigh and neck, in the accident near Mumbai on Sunday. This caused multiple injuries to vital organs, leading to his death. Along with viscera, his blood samples have been preserved for further analysis.

Jehangir Pandole, who was seated on the back seat of the vehicle along with Mistry, also died after sustaining similar injuries. "Other than multiple fractures both of the deceased sustained blunt injuries in their vital organs due to the impact of the accident which caused internal bleeding. ## Mutt head in judicial custody till September 14

Bengaluru: A local court in Chitradurga on Monday sent Sri Jagadguru Murugharajendra Mutt head Shivamurthy Sharanaru to judicial custody till September 14.

Chitradurga police produced Shivamurthy in the court on Monday at the end of his threeday police custody. The police informed the court of Second Additional District and Sessions Judge B K Komala that no more need Shivamurthy's custody.

The hearing on the bail application moved by Shivamurthy's counsel has been listed for September 7 and the police have asked the public prosecutor to file objections, if any.

The Mysuru police lodged a complaint against Shivamurthy on August 26 under the Protection of Children from Sexual Offences (POCSO) Act, 2012, and Section 376 of the Indian Penal Code (IPC) pertaining to rape. **ENS** 

# Cops need to apply laws with honesty, impartiality: Teesta

Ahmedabad: Social activist Teesta Setalvad Monday said if police fail to apply laws with honesty, impartiality and autonomy and get away without following the due process related to arrest, then it can become a threat to anybody and not just campaigners.

"We have a set of laws in this country-IPC (Indian Penal Code) laws and other laws —and those laws need to be applied with some degree of honesty and with some degree of impartiality and autonomy by the po-

lice," Setalvad told news channel NDTV two days after her release on interim bail from the Sabarmati central jail in a case of fabricating evidence to frame "innocent people" in the 2002 Gujarat riots cases.

The Mumbai-based activist, arrested in June-end, was granted interim bail by the Supreme Court last week after spending 70 days behind bars (63 days in jail and seven in police custody).

Citing the example of factchecker Mohammad Zubair, who was arrested in June in a case of allegedly hurting religious sentiments through his tweets and later granted interim bail by the Supreme Court, and others subject to the so-called "crackdown", she said the question here is the police not becoming an arm of the executive. Setalvad said the Constitution gives right to people who feel they are being discriminated against by the state. 'That right cannot be taken away from the individual," she said. PTI


